 The Commissioner of Police has proposed that the vacancies occurring consequential upon the retirement of the undermentioned Commissioned Officers under the provisions of the Police Act 1937-1985 be now filled:

Vice Superintendent R. Rigney who retired on 16 December 1985. It is proposed that this vacancy be filled by an Inspector.

. Criminal Investigation Branch Brisbane Vice Inspector G. E. Seib whose assignment from Criminal Investigation Branch, Brisbane, to Longreach Police District was approved by Executive Council on 20 February 1986.

- The Commissioner has submitted recommendations for promotions and assignments to fill these vacancies as set out in the attached Schedules (two).
- 4. The Commissioner has recommended that Superintendent J. M. Donoghue be promoted to the rank of Assistant Commissioner to fill the vacancy occurring on the retirement of Assistant Commissioner D. F. McDonald.

Superintendent Donoghue was sworn in as a member of the Police Force on 26 February 1951 and served in the uniform section at Roma Street and Ingham prior to taking up criminal investigation duties in 1954. As a Detective he served at Ingham, Warwick and Criminal Investigation Branch, Brisbane.

The Superintendent was appointed to Commissioned Rank on 21 January 1980 and assigned to Office of Commissioner of Police (Training). He later served in assignments at Internal Investigations Section, Queensland Police Academy, Chelmer Police College (in charge), and Criminal Investigation Branch, Brisbane. Since November 1982, he has been assigned to Office of Commissioner of Police (Training) in which assignment he was promoted to the rank of Superintendent on 9 May 1983.

Throughout his service Superintendent Donoghue has displayed outstanding dedication, loyalty and efficiency. His performance as a Commissioned Officer particularly in the training and development area of the Force fits him well to take over the duties of the position presently held by Assistant Commissioner D. F. McDonald, i.e. Assistant Commissioner (Training and Legal) and the Commissioner is firmly of the opinion that he is the most suitable Commissioned Officer for elevation to the rank of Assistant Commissioner.

- 5. In recommending the promotions of four Inspectors to the rank of Superintendent, a number of Inspectors are being passed over. The Inspectors recommended for promotion are considered to possess superior qualifications for the particular assignments for which they are being recommended. I would mention also that a number of the Inspectors passed over have expressed a desire to remain in their present assignments at this stage or have been selective in their preferred assignments.
- 6. In the recommendations for the promotions of Senior Sergeants to the rank of Inspector (Grade 3), no Senior Sergeants who have successfully completed the Commissioned Officers Course at the Queensland Police College have been passed over.
- The Commissioner has proposed the promotions and assignments of Commissioned Officers of Police as detailed in the attached Schedules (two) and I agree with his recommendations.

RECOMMENDATION

I recommend that the approval of the Governor in Council be sought for the promotions and assignments of Commissioned Officers of Police as detailed in the attached Schedules (two).
