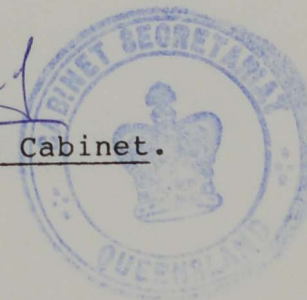


QUEENSLAND PLACE NAMES ACT 1988

PLACE NAME FOR OMISSION

1. The Queensland Place Names Act 1988 requires that a proposed omission of a place name be submitted to the Governor in Council for approval.
2. The Pine Rivers Shire Council requested the Surveyor-General in February 1989 to give consideration to the omission of the suburb name 'Wyllie'. The Council proposed that the area known as 'Wyllie' be added to the existing suburb of 'Lawnton'.
3. The Council submitted that a majority of the occupants of commercial premises in the present 'Wyllie' favoured a change of their address to 'Lawnton', as 'Wyllie' was not recognised by their clients.
4. The proposal to omit 'Wyllie' was published in the Queensland Government Gazette on 10th June 1989. It was also advertised in the appropriate regional media.
5. The Surveyor-General received four objections to the omissions from descendants of Alexander James Wyllie, after whom the suburb was named. None of the objectors reside in the area concerned.

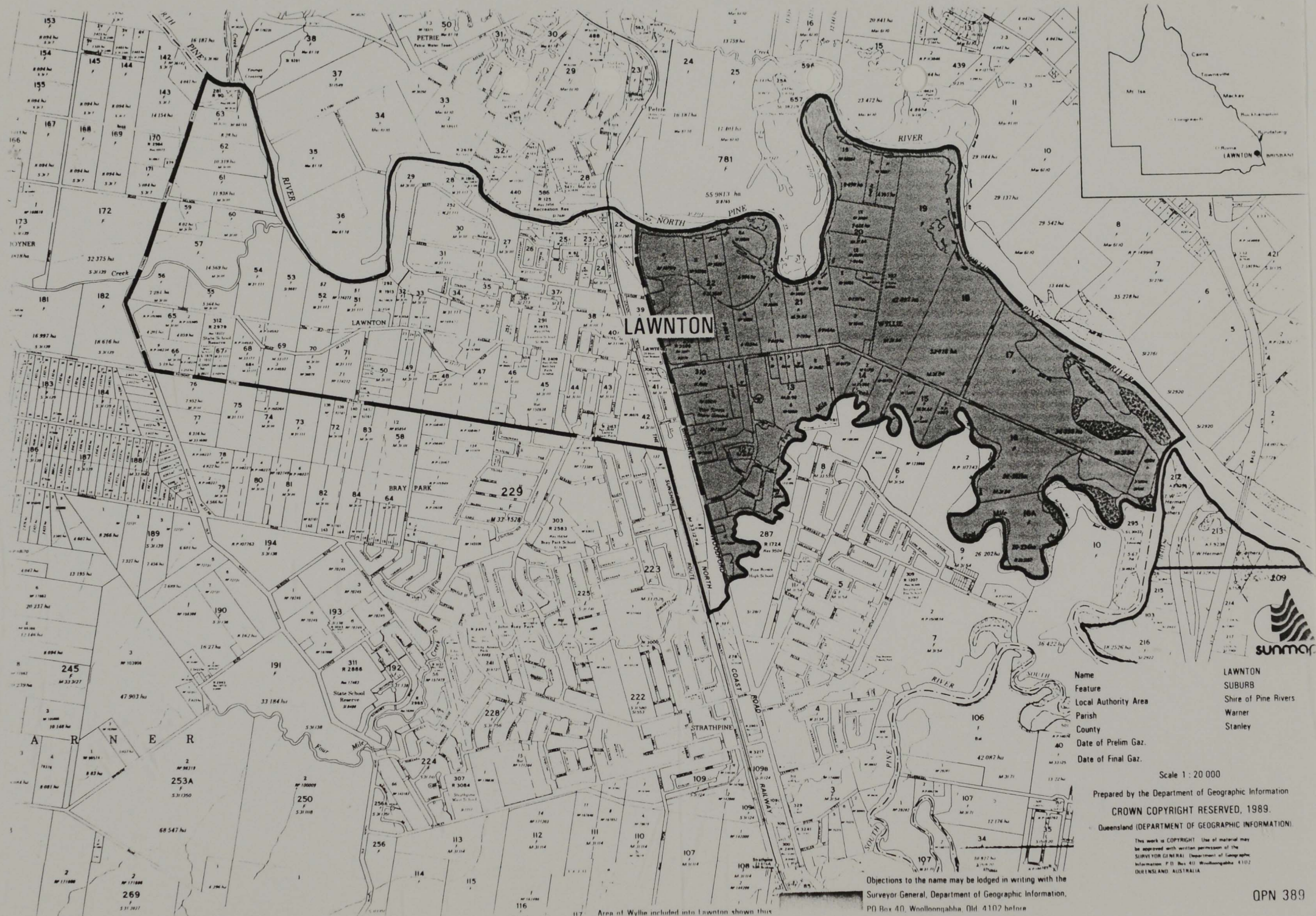
6. After consideration of a report by the Surveyor-General on the content of the objections, I have decided not to uphold them.
7. I therefore recommend that it be a recommendation to the Governor in Council that the suburb name 'Wyllie' be omitted, and that the area formerly known as 'Wyllie' be added to the suburb of 'Lawnton', within the Shire of Pine Rivers.
