GRIGORI PETROVITCH PAVLENKO of South Brisbane aforesaid
Labourer holding and exercising the offices of Prior
Secretary Church Warden and Assistant of the Church Warden
respectively in accordance with the rites rules and usages
of St. Nicholas Russian Orthodox Church and their
successors forever holding the offices aforesaid were
incorporated under the name or style of "St. Nicholas
Russian Orthodox Church".

2. I this deponent am the duly appointed Rector for the
time being of St. Nicholas Russian Orthodox Church for the
Parish of Brisbane in the said State.

3. I this deponent by virtue of my religious office as
aforesaid was the Chairman of a meeting of the accredited
members of the Parishioners Committee of the said Church

The paper writing hereto annexed and marked "A" is a true and correct translation by me of a copy of Statement 197 Section 1 from the Minutes of Proceedings in the said Parishioners Committee relating to the Appointment of Trustees referred to in Clause 4 hereof which said Minutes were written in the Russian language.

6. All the facts and circumstances herein deposed to by me are within my own knowledge save where deposed to from information only and my means of knowledge and sources of information appear on the face of this my Affidavit.
